## 2018 Budget & Dues

In October of 2017, the 2018 budget was adopted. Monthly fees remained unchanged:

- Single Family Homes \$84.30
- Townhomes \$99.00

The budget for 2018 represents a continuation of services and required savings for the community including but not limited to snow removal for the townhome area, grounds maintenance, pool services, community events, and the annual summer bash.

#### **Architectural Submission Form**

Now is the time to perform maintenance to your home exterior and landscape. This form will need to be completed and approved prior to the modifications listed in the Cascades Park handbook.

## **Groundskeeping Contracts**

Genesis Landscapes will continue to provide landscaping services within the community. A contract to have fallen trees and debris removed from tree save and tree lines is being finalized and will be completed in June. Snow removal for 2018 in the townhomes will be performed by GLM Services in the townhome community during the winter season. \*As a reminder, snowplowing for the single family homes is provided by VDOT.

# Sense of Community

The Board continues to manage the overall community improvement plans (to include landscaping, renovations to the clubhouse, tot lot improvements, and other efforts) via a 5 year plan. As needed, professional services are consulted to provide guidance and advice.

# Safety and Security

As the school season is coming to completion, please be alert for children at play. Also, please be mindful of our community parking policies. Campers, Recreational Vehicles (RV's), Commercial Vehicles and Boats are prohibited within Cascades Park. # Fiscal Discipline

The Board continues to manage total assets of approximately \$1.3 million while fully funding our reserves. While still early in the year, we are on track to meet our approved 2018 budget, including expenses driven by snow removal.

# Adherence To Governing Documentation

In an effort to recognize lessons learned within the community, the Board authorized the Covenants Committee to submit an update for consideration of the Community Handbook. ## Maintenance of Property Values

The Board recognizes that the community is aging and is taking steps to maintain and increase property values for homeowners. Individually, we can all take pride in our properties and maintain structures, landscaping, and the overall look of the neighborhood.
