I. CALL TO ORDER & VERIFICATION OF QUORUM

Mr. Weltens called the meeting to order at 7:08 p.m. and verified a quorum was present.

II. OPEN FORUM

A resident came to the meeting to discuss what the Board is planning to do about the tennis courts specifically, with repairing them and adding pickleball lines to the courts. Mr. Weltens stated that the Board is planning to fix the surface of the court and then explore adding lines so that the courts could be used for pickleball as well. III. COMMITTEE REPORTS

- A. Covenants Committee: Ms. Daum reported that the Covenants Committee has received two applications since last month's meeting, which both have been reviewed and processed. The Board reiterated that homeowners are required to file an ARB application for changes made to the exterior of their homes. The application is reviewed by the Covenants Committee and the homeowner cannot make any changes until the application has been approved by the Covenants Committee.

- D. Social Committee: Ms. Lathrop stated that the Social Committee is planning a Yard of the Month contest during the summer months in lieu of the Spring Curb Appeal Contest. The Social Committee is also planning events on Sunday, June 5th, and Labor Day weekend to celebrate the opening and closing of the community pool for the season.

at the monument area in front of the community pool. The motion passed unanimously (4-0-0).

B. Pool / Bathrooms:

MOTION: Ms. Lathrop moved, Mr. Weltens seconded, to approve the proposal from District Builds LLC in the amount of \$8,750.00 (Proposal # 7265) for redoing the bathroom floors, exhaust fans and sink traps at the community pool. The motion passed unanimously (4-0-0).

C. Tennis Court RFP: Management will gather feedback from the Board and request a revised RFP for the tennis court.

VII. OLD BUSINESS

A. Discussion – Survey Update: The Board discussed additional ideas for updates / enhancements to the retaining wall, clubhouse, pool, and sidewalk area, and adding a trash can alcove.

VIII. NEW BUSINESS

A. Pool Mailing: The Board asked Management to make some changes to the proposed mailing about the upcoming pool season.
